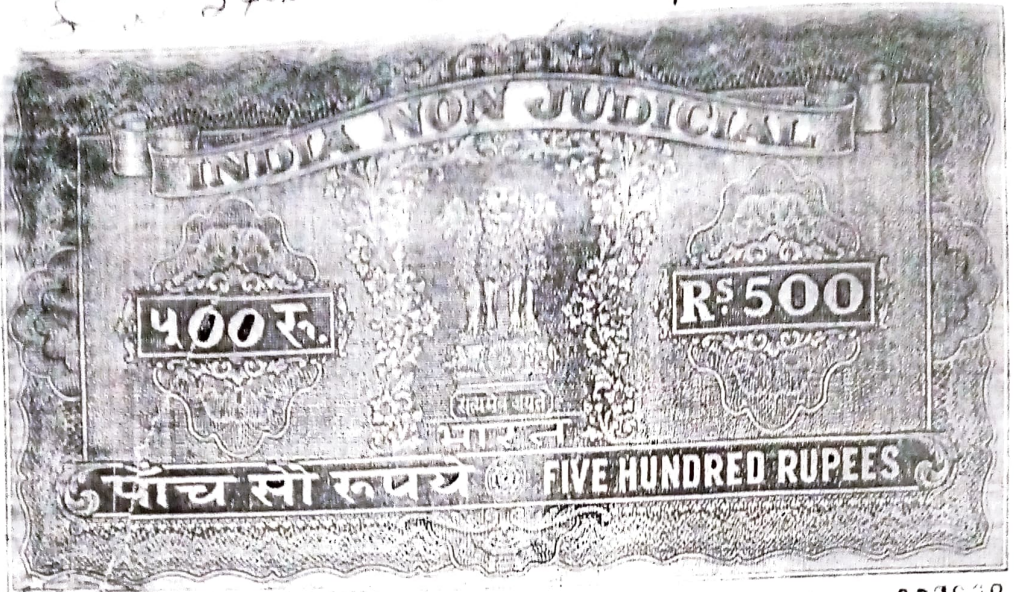

3. OBJECT CLAUSE :-

MAIN OBJECTS FOR WHICH THE TRUST IS CREATED :-

- (a) The work for the advancement of educational science and Health.







- (b) To establish, run and maintain schools, Technical Institutes, Colleges and Research Institute (s) as per the law time being in force and as per the requirement of society.
- (c) To establish maintain and run academic training center (s) and Guidance and Coaching Bureaus.
- (d) To establish run, and maintain book banks, libraries and reading room.
- (e) To establish run, and maintain Hostels to provide lodging facilities for the poor and needy students and their teachers and to run and maintain hostels for the students of the mentioned institutes.
- (f) To establish, run and maintain medical colleges, engineering colleges and research Institutes.
- (g) To establish, run and maintain agricultural, technical and handicrafts training centers as may be permissible by law and requirement of the society.
- (h) To provide social service to rehabilitate and assist the handicapped, mentally sick and crippled and to provide assistance to displaced persons.
- (i) To establish a common health and hygiene's programs.
- (j) To provide financial assistance and scholarships, stipend, grants to students and any other person/ students to whom the trustees think fit.

- (l) To establish hospital, nursing homes, clinics, dispensaries, health centers,
- (m) To establish orphanages, old people homes and rehabilitation centers

- (a) To accept any donation, contribution grant or subscription in cash or kind from any person (s) or trust to carry out the object referred to.
- (b) To convert and deal with the trust property and or any investments for the time being.
- (c) To invest the Trust Fund either in the purpose of mortgage of immovable property or in shares, stock or debentures ~~another securities and investments or in deposit with~~ or loans to any company bank, firm or any other person, and to alter, vary or transpose such investments from time to time at the discretion of the trustees.
- (d) To sell, dispose of, alienate or other wise deal with any property comprising the Trust Fund.
- (e) To let out demise any immovable property comprised in the Trust Fund for such period and at such rent on terms and conditions as the Trustees in their discretion may think fit.
- (f) To open account in the name of Trust, trustees and / or Institutions run/conducted by the Trust with a bank or banks to operate such account and to give instructions to the bank and to provide for opening and operation of such account by one or more of the Trustees or by an agent appointed by the Trustees.
- (g) To adjust, settle, compromise, compound refer to arbitration all actions, suits claims, demands and proceedings regarding the Trust Fund.

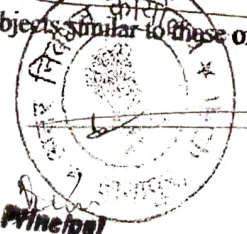

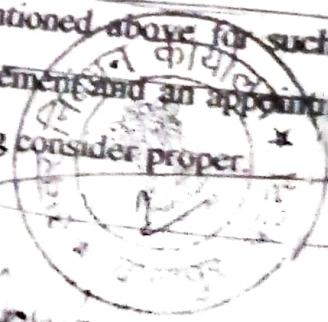

- (c) If the trustees desire to co-opt another eminent personality as trustees for betterment of Trust, they can co-opt but total number of trustees shall not be more than seven.
- (d) If any vacancy made in board of Trustees, these vacancy can be fulfilled by co-option.
- (e) The Trustees will not be entitled to receive any remuneration, but the Trustees may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating there to.
- (f) The Trustees shall be accountable only for such moneys, stocks and funds as shall actually come into their hands and a Trustee shall not be answerable or accountable for neglect, default, acts or omission or commission of the other trustees nor of any banker or other person with whom the trust properties or any securities may have been deposited or kept.
- (g) The number of the Trustees shall not less than two and more than seven. If the number of the Trustees shall fall below two, Trustees shall not except for the purposes of filling any vacancy act so long number is below the minimum.
- (h) The managing Trustees for the time being will be at liberty to appoint additional Trustees within the number mentioned above for such period or on such terms as to retirement and an appointment as the trustees for the time being consider proper.

(i) A person shall cease to be a Trustee either:-

(1) If he without leave of absence does not attend three consecutive meetings of the Trustees or for one calendar year which ever is longer

or

(2) If he is requested to resign by $3/4^{\text{th}}$ or as near there to as possible of the remaining Trustees.

6. ACCOUNT CLAUSE :-

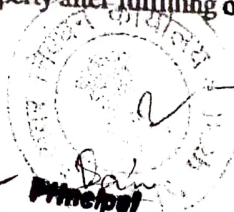
(a) The accounting year of the Trust shall be the financial year ending on 31st March every year.
